#### **CHAPTER I**

### 1.1 Background of the Study

A film is a type of media that uses audiovisual elements to convey information to a group of people gathered in a specific location (Effendi, 1986:134). For many people worldwide, the film appears to be a place to escape reality. Previously, films were created solely for entertainment, documentary, education, or to tell a story about something or someone, whether actual or just fiction. Nowadays, the film industry has improved a lot. A film is a combination of audio and visual. Because it is an audiovisual aspect that includes both vision and sound, the film has the potential to be a medium of communication for the targeted masses. A movie with pictures and sound may tell many stories in a short amount of time. A film can be used as a medium to collect an approach related to social theory, social phenomenon, and other sciences getting discussed or even criticized of the movie. A film also describes social or individual problem phenomena that reflect our daily lives. One of them is about psychological phenomena that happen in our society. When watching a film, the audience seems to be able to penetrate the space and time that can tell the life and even influence the audience.

Typically, a film is an adaptation of literary works in prose, particularly novels, which are long-form human portraits existence. It can use to investigate human nature as a substance. In a film, different types of human nature and life phenomena are mirrored, including mental illness. For example, if someone is traumatized by being in love because they do not want to hurt when they break up, they will strive to avoid falling in love as a protection mechanism.

A defense mechanism is a psychological method used by individuals, a group of individuals, or even a country to deal with reality and maintain a sense of self-worth. Throughout their lifetimes, healthy people employ a variety of defense mechanisms. When someone overuses their defense mechanism, it becomes pathological, causing a person to become maladaptive/unable to adapt well, affecting their bodily and mental health. The defense mechanism's purpose is to protect the mind/self/ego from anxiety, trauma, and social punishments and to provide a location of "displacement" from situations that cannot to handled. In this study, the researcher wants to discuss using defense mechanism theory. An individual's ego defense mechanism is a defense tactic used by the ego to counteract the id and superego pressure on external reality. Individuals' defense mechanisms assist them in carrying out the automatic rejection function of undesired instincts while protecting them from excessive distress. The researcher chose this explanation because it corresponds to Teddy's protection mechanisms as he recovers from his trauma. A defense mechanism is a form of self-defense that humans naturally do.

Literature has now become an integral component of people's lives. Literary works are done based on two things, namely fiction or based on personal experiences. Sigmund Freud developed psychoanalysis as a philosophy for examining human psychology. According to him, the subconscious, which includes the id, ego, and super ego, is in charge of human behavior. Experts criticized and responded to aspects of Sigmund Freud's outstanding work, particularly his theories of dreams and sexuality. It is necessary to apply psychological concepts to children. That is, when it comes to developing and educating kids, education must also consider the concept of psychoanalysis. Paying attention to the concept of psychoanalysis is one of them. According to Heinrich, human beings have basic desires and requirements. (Cherry, 2020)

In shutter Island movie 2010, the story is about Teddy, a marshal agent from the United States who went to the Ashecliffe Hospital for the mentally ill on Shutter Island in the Boston Harbor area. He went with his friend named Chuck Aule. He rushes to the hospital for an urgent investigation regarding the disappearance of Rachel Solando, a patient. Rachel Solando was apprehended after her children died after she drowned in the lake behind their house.

After Teddy and Chuck arrived, a hurricane hit the island, and they could not return home for several days. When Teddy asked Dr. John Cawley, the chief psychiatrist, to release hospital staff records, he refused. Dr. Sheehan, Rachel Solando's doctor, went on vacation after she vanished. They were also prohibited from entering ward C during the investigation and the island's lighthouse. Realizing the oddities, Teddy finally decided to enter ward C and the lighthouse on the island to find out what happened. During his investigation, he uncovers shocking facts about the Ashecliffe hospital. In the middle of the investigation, he experienced several severe migraines and hallucinations about a woman, namely Dolores' wife.

The researcher is interested in searching this film that started as a mystery surrounding the events the main character and the psychological condition of the main character. At the beginning of the Movie, Teddy is characterized as a marshal who will investigate Rachel Orlando, one of the patients at Ashecliffe Hospital that was disappeared. During the investigation, he began to notice inconsistencies at the hospital, prompting him to probe deeper. He started having migraines and hallucinations in the middle of the investigation. One by one, the facts emerge: who is Teddy, what has he been through in the past, whether everything that occurs is a hallucination or not, what causes the hallucinations, and how he attempts to recover from his mental illness. The key reason for the researcher's interest in this film is because it aims to uncover the truth about the psychological condition of the main character, played by filmmaker Martin Scorsese.

Therefore, the first step researcher is finding the resources, like finding the film, the script of that movie, and finding any journal related to the topic chosen by the researcher. The second step is for the researcher to watch that movie while reading the movie script., the researcher will read the movie script and watch the movie to find the defense mechanism of the movie's screenplay and the theory of defense mechanisms. After the researcher has read,

understood, and watched the movie's script and theory, the researcher identifies the next step: the objective problem. After the researcher gets the data, the researcher continues interpreting the data supporting the theory. The researcher uses Sigmund Freud's defense mechanism theory at the data analysis stage.
