# CHAPTER I INTRODUCTION

Severus Snape was an English wizard who served as Potions Teacher (1981-1996), professor of Defense Against the Dark Arts (1996-1997), and Principal (1997-1998) of the School of Witchcraft and Wizardry. Severus Snape as well as members of the Order of the

Phoenix and Death Eaters. His double life played a very important role in both Wizarding Wars against Voldemort. Tobias Snape, a human or muggle, and Eileen Prince, a witch, gave birth to Severus Snape, a wizard. He was Lily Evans' (Harry Potter's mother) acquaintance. The most well-known character is Severus Snape.

In the 'Harry Potter and the Deathly Hallows part 2' book, It is maintained that Snape serves an essential function on his own and not merely in regard to Harry (Schanoes 142), a position that this essay supports. The portrayal of Snape grows increasingly complicated, reflecting the greater focus on his multiple nature. According to Peter Applebaum, Harry's development as he gets older and learns more about his fate and the world around him is reflected in Snape's ambiguity. Harry has a very negative initial opinion of Snape. Before analyzing Snape in connection to the other characters, we must first look at Snape more closely and understand his characteristics.

Structuralism is a philosophy and method that developed from insights in the field of linguistics in the mid-20th Century to study the underlying patterns of social life. Gough states that, structuralism is a conceptual and methodological approach to describing and analyzing a variety of objects of inquiry including, for example, cultures, economics, language, literature, mythologies, politics, and societies.(Gough, 2010) According to Levi-Strauss, the human mind organizes information through binary opposition, or the comparisons of two things that are incompatible. Cultures are influenced by this binary opposition to think of good and

bad. Structuralists believe that the underlying structures which organize rules and units into meaningful systems are generated by the human mind itself and not by sense perception. Kendra states that structuralism played a role in the drive to make psychology a more experimental science, while functionalism laid the groundwork for the development of behaviorism (Kendra, 2020). You can better grasp how psychology came to be the discipline it is today by comprehending these two schools of thinking.
