

## ABSTRACT

Imagery is a literary device that helps readers visualize scenes, hear sounds, feel textures, taste flavors, or smell aromas through words. This research aims to explore the death imagery evoked in readers by the poems '*On Death*' and '*When I Have Fears*' by John Keats, using Perrine's theory as a framework. The study employed a qualitative descriptive approach, involving a close reading and interpretation of the poems to identify and analyze the use of imagery and metaphor. Perrine's theory served as the theoretical framework for this analysis. The study focuses on two of Keats' poems, '*On Death*' and '*When I Have Fears*'. The findings revealed that '*On Death*' used four different types of imagery: visual imagery, kinesthetic imagery, tactile imagery, and organic imagery, while the poem '*When I Have Fears*' also included the same four types of imagery: visual imagery, kinesthetic imagery, tactile imagery, and organic imagery. Furthermore, the types of metaphor in the poems '*On Death*' that were found were standard metaphor, visual metaphor, implied metaphor, extended metaphor, and mixed metaphor, while the poem '*When I Have Fears*' also included the same types of metaphor: standard metaphor, implied metaphor, visual metaphor, extended metaphor, and mixed metaphor. Meanwhile, the research identified the implied meanings of imagery and metaphor in the poems '*On Death*' and '*When I Have Fears*'. In addition, the research also identified the relation between imagery and metaphor in the poems '*On Death*' and '*When I Have Fears*'.

Citraan adalah perangkat sastra yang membantu pembaca memvisualisasikan adegan, mendengar suara, merasakan tekstur, merasakan rasa, atau mencium aroma melalui kata-kata. Penelitian ini bertujuan untuk mengeksplorasi citra kematian yang dibangkitkan pada pembaca melalui puisi '*On Death*' dan '*When I Have Fears*' karya John Keats, dengan menggunakan teori Perrine sebagai kerangka kerja. Penelitian ini menggunakan pendekatan deskriptif kualitatif, yang melibatkan pembacaan dan interpretasi puisi secara cermat untuk mengidentifikasi dan menganalisis penggunaan citra dan metafora. Teori Perrine berfungsi sebagai kerangka teori untuk analisis ini. Penelitian ini berfokus pada dua puisi Keats, '*On Death*' dan '*When I Have Fears*'. Temuan penelitian mengungkapkan bahwa '*On Death*' menggunakan empat jenis citraan yang berbeda: citraan visual, citraan kinestetik, citraan sentuhan, dan citraan organik, sementara puisi '*When I Have Fears*' juga mencakup empat jenis citraan yang sama, termasuk citraan visual, citraan kinestetik, citraan sentuhan, dan citraan organik. Selanjutnya, jenis-jenis metafora dalam puisi '*On Death*' yang ditemukan adalah metafora standar, metafora visual, metafora tersirat, metafora diperluas, dan metafora campuran, sedangkan puisi '*When I Have Fears*' juga memiliki jenis-jenis yang sama, yaitu metafora standar, metafora tersirat, metafora visual, metafora diperluas, dan metafora campuran.
