## Abstract

This research uses a qualitative analysis method with a descriptive approach. Data were collected through literature review and text analysis of the novel “*The Awakening*” by Kate Chopin (1899) as the main technique to explore the themes of gender inequality that appear in the narrative, with an emphasis on analyzing patriarchal power and systemic oppression of women. This research aims to examine the gender inequality experienced by the female protagonist in the novel “*The Awakening*” through the perspective of feminism studies, particularly the radical feminist theory proposed by Kate Millett. The novel “*The Awakening*” describes the struggle of a woman, Edna Pontellier, in facing social norms that limit her freedom and identity as an individual. This research finds that the main character, Edna Pontellier, experiences various forms of gender inequality reflected in the social, economic, and cultural restrictions imposed on her as a woman in the late 19th century. Using Millet's radical feminist theoretical framework, this research explores how the patriarchal structure in the novel affects Edna's life and decisions. This analysis provides an in-depth understanding of women's struggle against gender injustice and the relevance of these themes in today's social and cultural context. Through the characterization of Edna, Chopin expresses a critique of patriarchal norms that limit women's freedom and identity. Kate Millett's radical feminist theory is used to analyze how patriarchal power structures affect Edna's life and decisions, as well as how she struggles to achieve independence and liberation from the gender norms that constrain her.

Analisis ini memberikan pemahaman mendalam tentang perjuangan perempuan melawan ketidakadilan gender dan relevansi tema-tema tersebut dalam konteks sosial dan budaya saat ini. Melalui karakterisasi Edna, Chopin mengungkapkan kritik terhadap norma-norma patriarkal yang membatasi kebebasan dan identitas perempuan. Teori feminis radikal Kate Millett digunakan untuk menganalisis bagaimana struktur kekuasaan patriarkal mempengaruhi kehidupan dan keputusan Edna, serta bagaimana perjuangannya untuk mencapai kemandirian dan pembebasan diri dari norma-norma gender yang mengekangnya.
