In this study I focus on the sexual mental disorder in the novel entitled *Trilogy Fifty Shades* by E.L James. The objectives of the study are to know what sadomasochism is depicted in novel *Fifty Shade Trilogy* by E.L James. The second is to identify the factors that cause main character sadomasochism in *Fifty Shade Trilogy* by E.L James.
