CHAPTER I

INTRODUCTION

1.1 Background of the Study

Being born as a woman is a destiny in life. The nature of a woman is to be a wife, give birth, and care of children. A struggle indeed, but it cannot be concluded that the woman's position is always under the control of men. A woman has the right to do anything that makes her comfortable and free without pressure from any party, including her mind. This movement was inspired by the thought of radical feminism by Kate Millett, she revealed in her book *Sexuals Politics* (1970) that relations gender is the relation of power and the root of operations against women buried in the sex system or gender in patriarchy. To free women from male domination, then patriarchy must be removed. Millett wants an androgen future, an integration of feminine and masculine traits. (Setyawan;2017:71)

The Duchess (2008) movie directed by Saul Dibbis a film adapted from a book entitledGeogiana: Duchess of Devonshire byAmanda Foreman. This film reflects the condition of an 18th century noblewoman and infidelity conflicts that made her family out of harmony. This phenomenon is a picture in the royal environment at that time. This is a clear fact that there are gender forces where

men are more dominant than women. The oppression experienced by the main character is evidence of the cruelty experienced in the patriarchal society. The main character rejected the concept of patriarchy and struggled to get the rights that women should get. The main character is a public figure which is very influential in society, besides her struggle to get equality of position and justice leads Georgiana has a feminist character.

As the main female character, Georgiana became the woman figure who built the character in the movie, which is willing to get married at a fairly young age, at 17 years old. Georgiana is said to be unlucky despite being a noblewoman who has everything. Living in an era where a woman must abide by the policies and all regulations of men makes Georgiana unhappy throughout her life. The injustice she experienced because she could not provide an heir made the husband betrayed and made Georgiana feel like a useless woman. Psychological oppression continues to be elaborated by the director during the end of the story and it has more value for the feminist theory approach.

Noble women of that era were still under the control of family with their noble titles.All aspects of life such as social, economic and romance were still benchmarks so that the nobility was not lost. Not all women in this era whose lives were full and wrapped in luxury mean "happy". Internal problems were a psychological problem experienced by most noble women because of oppression.The highest social class in pre-modern society was "nobility". In most countries, "noble status" does not have official privileges; except in the United Kingdom.Based on the article of European Royal History-*Exploring the History* of European Royaltyin Kingdom of Europe,Duke it derives from the Latin, dux meaning leader. It was first created in England in 1337 when King Edward I made his son, Edward the Black Prince, Duke of Cornwall.
