### **CHAPTER I**

### INTRODUCTION

Chapter I is the beginning part of this study. This chapter contains the introduction of the study that regarded as the basis for the researcher in writing the study. It explains the background of the study, statement of the problem, objective of the study, scope of the study, significance of the study, approach to the study, and organization of the paper. Those explanations are there in seven subsections as follows:

## 1.1 Background of the Study

Human are meant to live as social being since thousands year ago. Every individual should get along each other by having interactions in order to fulfill their needs, develop themselves, and reaching their goals. Yet, in reality, human interaction activities are not always running well. There always be parties who win and lose because of the existence of different classes, social statuses, ideologies, perspectives, and power. Therefore, it triggers conflicts and discriminations among societies.

Conflict and discrimination are two obstacles that create disharmony situation in human interactions. Disharmony situations possibly appear in any relationships of groups of people; including the relationship between man and woman in society. Disharmony between man and woman can also called as "gender-based discrimination". Gender-based discrimination is an example of conflicts which exist in society in which positions one of the genders over

another. This phenomenon comes to the result that status difference between man and woman in society is created. One tends to be the dominant and powerful, while another one tends to be the submissive and should not be powerful.

Gender-based discrimination is one of many kinds of discrimination ever exist in this universe. It has been a crucial issue yet it is also often ignored by society. This phenomenon happens because the ideology of patriarchy has made it be a common thing in society. The patriarchy ideology influences and creates such a hegemony to people in their behavior, way of life, and social structure. Then, it becomes a social standard in many patriarchal societies, and most people accept it as a part of culture and custom that nurtured continuously from the ancestors to the offsprings. Therefore, it creates a sexist mindset in society which follow this way of life. It comes to the result that men become the dominant who are superior to women, while women become the subordinate who are inferior to men. Gender equality means nothing in society with patriarchy ideology.

According to its meaning, gender is a socially constructed term for attitudes, activities, roles and traits that are considered appropriate for men and women (Shastri, 2014:27). Discrimination itself defined as a hindrance on achieving the objectives of equality, peace, and development (Pokharel, 2008:1). While, gender-based discrimination is inequality which exists between two sexes which are men and women.

Talking about gender-based discrimination in the movie *On the Basis of Sex (2018)*, which is the analysis object of this research, also has reciprocal relationship with gender-based discrimination in real life society. The storyline of the movie adapted from the experience of American women activist, Ruth Bader Ginsburg, who courageously revealed the fact of gender-based discrimination that happened in the United States in the 20<sup>th</sup> century. She tried to find justice over gender-based discriminations in the country. In this case, the gender-based discrimination not only happen to women but also men that in the movie experienced by Charles Moritz, a man who asked for tax deduction. Therefore, there is a close relationship between the movie and the society, especially among American society.

Gender-based discrimination which is the topic of this research, will be analyzed using the point of view of feminism. Feminism itself is closely related to the issue of discrimination based on sex, especially discrimination against women, which occurs in various parts of the world. The existence of feminist ideology or movement is considered to be a way out of the problem of gender inequality which has been the cause of discrimination against women for centuries.

For centuries, in various cultures around the world, women are considered as submissive creatures whose existence is not as important as the existence of men who are the dominant party in society. The world of women is limited to domestic matters; taking care of children, cooking, cleaning the house, watering

the plants, etc. Women are not given the opportunity to have more room for movement, such as attending higher education, engaging in government structures, having the right to vote in elections, and taking roles in a higher realm than just taking care of domestic matters.

Therefore, based on the explanations above, the researcher chooses Depictions of Gender-based Discriminations in the U.S. in Mimi Leder's On The Basis of Sex (2018): As a Feminism Study as the title of the study.

### 1.2 Statement of the Problem

# 1.6 Approach to the Study

Feminists have also acted to ensure access to social integration and legal abortions, and to protect girls and women from any kinds of sexual abuse and domestic violence. (Echols, 1989:1967–1975)

In specific, the writer does the analysis based on Simone de Beauvoir's feminism theory. In her book entitled 'The Second Sex', specifically in the volume 1, she asserted that man is regarded as default, while woman is regarded as "Other"; an object whose existence is defined and interpreted by the male, who is the dominant in society. (De Beauvoir: 1949)

The data gathering and analysis of this research use qualitative method. According to Pope & Mays (1995), qualitative research is a concept development that assists us to understand social phenomenon in natural settings, providing appropriate emphasizing to the experiences, meanings, and the participant's views. Therefore, this research does not require numeric data.

The research is done by doing classification over the discourses and the scenes that cited in the movie script that related to the statements of the problem. Then, the researcher do the analysis by applying feminism approach through the gathered data. After doing analysis, the researcher takes conclusion and suggestion over the result of the analysis.

## 1.7 Organization of the Paper

This study will be divided into five chapters. The chapters detail are as follows:
