#### Abstract

Gender-based discrimination is one of many kinds of discrimination ever exist in this universe. It has been a crucial issue yet it is also often ignored by society. This phenomenon happens because patriarchy ideology has made it be a common thing in society. The patriarchy ideology influences and makes people hegemonized in behavior, way of life, and social structure. Related to this research, it is mainly discusses about the depictions of genderbased discrimination in the U.S. which found in the movie 'On the Basis of Sex (2018)' by Mimi Leder. The aim of this research is to find out the causes, the depictions, and the ways the main character take actions to overcome gender-based discrimination in the U.S. according to the movie. #### THEORITICAL FRAMEWORK

#### **Previous Studies**

The first previous study is from Andrey Shastri with title "Gender Inequality and Women Discrimination" published in 2014, which taking data from gender discrimination happened in India. This study aims to create elaboration about gender discrimination that faced by women and provides the society solution on how to lower it, and the finding of the study reveals that Indian society needs a social awakening and a shift of attitude of mindset in addition to making laws and enforcing the society itself, so that no more gender based discrimination and women obtain their rights of equality. The third previous study entitled "The Reflection of Marxist Feminism in Suzanne Collins's Mockingjay" by Nailah published in 2016. The aim of this study is to understand more about Marxist feminism in Mockingjay. This study applied qualitative method which analyze Mockingjay novel as the object using Marxist feminism approach. The findings of this study are the intrinsic and extrinsic elements of prose analysis. The intrinsic elements

which discussed are character, conflict, allegory, and setting. While the extrinsic element analysis discusses Katniss Everdeen as the main character in the novel Mockingjay. The extrinsic element analysis provides descriptions of alienation, class struggle, Marxist feminism, and domination. (Nailah, 2016:1)

While from the man side, Charles Moritz, he experienced discrimination in the field of law. It is when his proposal for caregiver tax deduction rejected by the court. The prevailing law proves that Moritz does not have the right for tax deduction since he is a bachelor and unmarried man who should not be a caregiver at home. This depiction represents sexism

#### CONCLUSION

Women regarded as obstacle and stranger to men in public although they appear as impersonal opponents (Beauvoir, 1949:199-200). Meanwhile, Charles Moritz is a representation of male character who experiences discrimination because he does not appear as how a man should be in patriarchal society. Thus it gets him into uneasy relation between him and his fellows (Beauvoir, 1949:201).

Ruth Bader Ginsburg presents as an independent and visionary female figure at the age. She is a proof that woman can go beyond expectation of society although they live under limitations. She has high ambition but still cares about the public interest. Despite experiencing discriminations in her community, Ruth remains tough and firm to her goals. The discrimination experienced by her does not prevent her from continuing to learn and develop until she achieves her goals one by one. With her desire to uphold justice and eliminate discrimination, she has taken the right steps and through her arguments she has succeeded in opening public minds about the massive discrimination that has occurred in the country.
