### **CHAPTER I**

# **INTRODUCTION**

#### **1.1 Background to the Study**

Most children's literature has simpler language and form; this is because their level of understanding of a story is still lacking. This is what distinguishes it from adult literature. Nevertheless, in children, it is more open to receiving fantastic and imaginative stories than in adults.

Hunt (1991:6) states that children literature is an educational and entertainment business. Entertainment business is the business side or the economy side that applies to the creative element such as writer, artists, celebrity, performers, musicians, and many more. Children's literature in the 18th century was more about fairy tales, and songs which were passed on by adults to children before the existence of printing media. A fairy tale gives children ideas and pleasure through stories that educate and contain kindness messages for children. One of the most famous fairy tales in the world is Cinderella. Cinderella's fairy tale tells the story of a soft and often abused girl, so helped by a fairy godmother who eventually reunites Cinderella with a prince. In the story, Cinderella comes to the party because of the magical help of the fairy godmother. Cinderella's story does not have a specific value system but has stable moral value content.

Cinderella's story's moral content may not be consistent for centuries; it is because the power of Cinderella's story is not in its morality but on who is telling the story. In essence, every Cinderella story tells the story of a daughter who is abused by her stepmother. Because of her good personality, Cinderella is helped by a fairy godmother, and in the end, Cinderella lives happily.

In a fairy tale, there are certain archetypes. According to Jung (1968), archetypes are a component of collective unconsciousness and serve to organize, direct and inform human thought and behavior. Jung (1968) outlined four main archetypes: the self (the regulation center of the psyche and facilitator of individuation), the shadow (the opposite of the ego image, often containing qualities that the ego does not identify with but possesses nonetheless), the Anima (the feminine image in a man's psyche) and the Animus (the masculine image in a woman's psyche). Other archetypes include the anima, the divine child, the great mother, the wise old man, the trickster, and the core or maiden (Carr, 2002).

This research focuses on the study of the fairy tale by Charles Perrault, which is Cinderella's story. The focus of the problems examined in this study is about Cinderella characters' personality in the short story titled 'Cinderella' and is included in what kind of archetypes the story is.

### **1.2** Statement of the Problem(s)

Based on the background of the above problems, the following problems can be formulated.

- 1. How does the personality of Cinderella as described in Cinderella's story and character?
- 2. What kind of archetype is reflected by Cinderellas's character in Cinderella story?
